# **Rules, Regulations & Important Vendor Information:**

### **DATE & HOURS:**

The fair will be held Saturday, October 1, 2016 from 10 AM-5 PM at Blessed Virgin Mary of Częstochowa Church, 250 Old Maxwell Rd., Latham, NY 12110.

### **SET-UP/ BREAKDOWN:**

Vendors are expected to set up between the hours of 6 PM-9 PM on Friday before the event and 8:30 AM and 9 AM, on Saturday. Break down can start no sooner than 5 PM on Saturday and must be completed by 6 PM. No vendor is to close before the official closing time. Sellers are responsible for their selling spaces. \*Before leaving, be sure your area is clean and trash-free\*.

### **SPACE ALLOCATION:**

The vendor committee will assign vendor spaces. Placement, flow and competition will be taken into consideration to provide the best experience for fair attendees. If you have special space needs, please include your request with your application and the committee will make every effort to accommodate you. Each crafter will get an 8x6 or 8x8 foot space and 2 chairs.

### STAFF:

Each vendor is responsible for the conduct of his employees and/or representatives and activities must not detract from the image or welfare of the fair. Vendor booths must be manned at all times. \*\*Holy Name of Jesus PNCC is not responsible for merchandise or display materials. \*\*
